Artist Statement - A detailed story about the creator, their artistic inspiration and the creation process of the **specific** artwork for viewer's understanding.

Blues22 is a funky blues groove. This blues is inspired by Miles Davis and his electric era explorations. This blues is actually inserted in my rearrangement of the song written by Marcus Miller for Miles Davis' electric era album titled Tutu. It is dedicated to Bishop Desmond Tutu. In the original recording the solo section is on a one chord funk groove. In my arrangement I inserted this blues chord progression which I devised as the solo vehicle. Bob Antolin is a producer, composer, band leader and multi-instrumentalist. He began playing the saxophone and guitar in elementary school and went on to get a music degree from the University of Washington. Loving classical music, jazz and music from around the world, Bob gets inspiration from every corner of the world. Bob was honored with the Golden Ear Award by Earshot Magazine for the Best Alternative Jazz Ensemble of the year in 2019 for his band, Comfort Food Band.


