Artist Statement - A detailed story about the work for viewer's understanding.

The original statue itself, David, is a masterpiece of Renaissance sculpture, created in marble between 1501-1504 by the Italian artist, Michelangelo. It is a 5.17 metre marble statue of the Biblical figure David, a favored subject in the art of Florence.

David was originally commissioned as one of a series of statues of prophets, to be positioned along the roofline of the East end of Florence Cathedral, but was instead placed in a public square outside the Palazzo Vecchio. The statue was moved to the Galleria dell'Accademia, Florence in 1873 and later replaced at the original location by a replica.

I have always been fascinated by Michelangelo, an Italian sculptor, painter, architect and poet of the High Renaissance, who's work had a major influence on the development of western art. -Particularly in relation to the Renaissance notions of humanism and naturalism. I wanted to represent this masterpiece in my own way. Using my feelings, my colors to give life to this ancient statue from the Renaissance period so that people may view this piece in the way I see it.

Instead of painting the whole figure, I wanted to paint only the upper part of the body particularly the face where I could depict its strength without showing the masculinity as created so finely by Michelangelo. Humbly enough, I have used the colors which are so unusual to this masterpiece and dare hope that one who sees this painting, can feel what I felt when I created my David.


