A secret meeting is organized with a kingpin, with the intention to overtake his operations and kill him. Unfortunately, the amateurs were slain in the process.

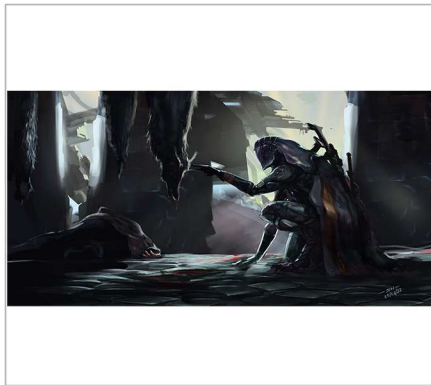

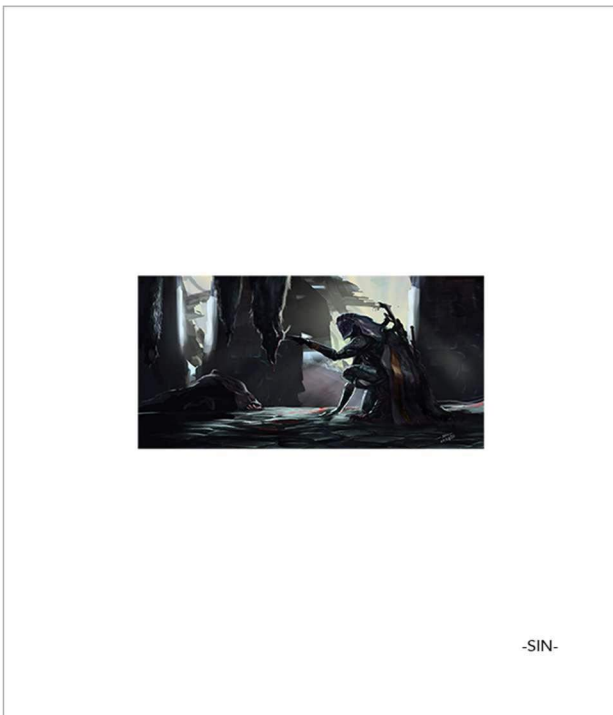

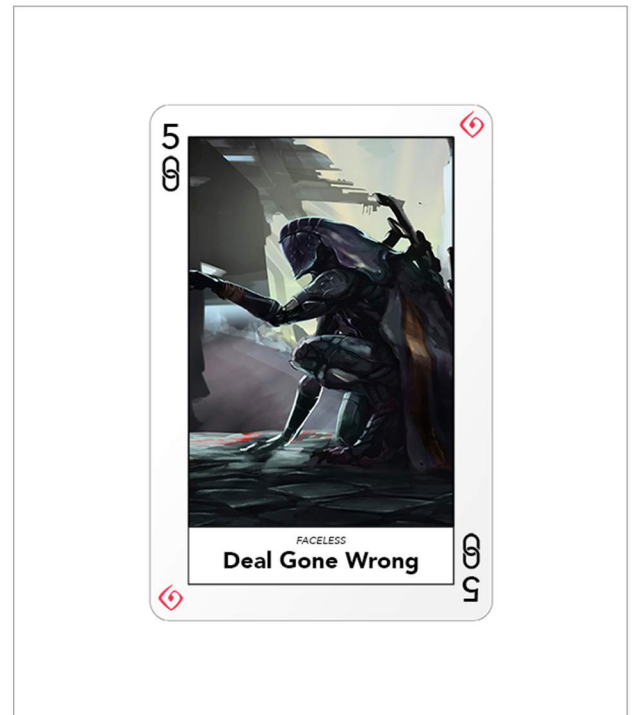
