The cathedral used to be the haven for sorcerers and clerics, but when the darkness fell the ground gave birth to creatures of the abyss.

One of five detailed doodle-style artworks from the Dark Magic collection by the artist doodleskelly, whose creative process relies on full-on intuitional improvisation. Most of his ideas depict whimsical dark fantasy worlds with psychedelic textures and colors, inspired by the likes of Moebius, Kentaro Miura, Hayao Miyazaki and many other japanese artists.
