In this vision, symmetry and chaotic shapes of nature create a peaceful scene for the viewer to take in the details. This fountain depicts legendary warrior spirits of an ancient prophecy, which has been long-forgotten. The fountains are common in the world of Dark Magic, and can be found from the many ancient, dilapidated ruins scattered around its landscape.

One of five detailed doodle-style artworks from the Dark Magic collection by the artist doodleskelly, whose creative process relies on full-on intuitional improvisation. Most of his ideas depict whimsical dark fantasy worlds with psychedelic textures and colors, inspired by the likes of Moebius, Kentaro Miura, Hayao Miyazaki and many other japanese artists.

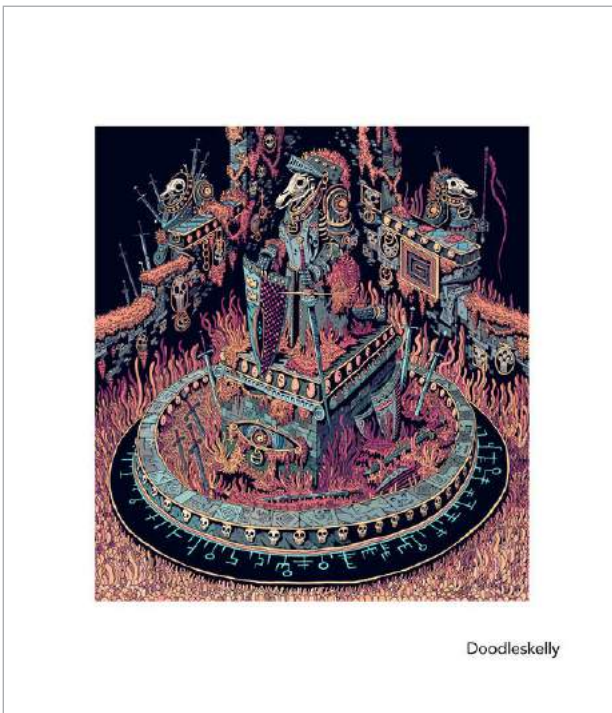
