Even if the Woodabe tribe is a patriarchal society, when it comes to sex...women are in charge. This is clearly demonstrated at the annual Gerewol fertility festival which culminates in a beauty contest where men compete and women judge.

This art piece depicts the character of three young men at the Gerewol ceremony, following the tradition and culture, to be chosen by their future wives. I made use of vibrant colors and different accessories like beads and shells to add value to their ornaments which they wear proudly during the contest.

I also feel connected to this nomadic tribe as they value color as much as a creator does. We both believe that colors have utmost importance in our lives.


