Artist Statement - A detailed story about the creator, their artistic inspiration and the creation process of the **specific** artwork for viewer's understanding.

Relay is a song inspired by the excitement of the 4 x 100 sprint relay, a summer Olympic event. The idea of this song is a metaphor of handing off the relay baton to the next runner in a smooth transition. This was recorded on an 8 track analog tape machine sync by time code to playback MIDI tracks. I have three instrumental solo features: vibraphone, electric guitar synth and soprano sax. The vibraphone and electric guitar synth are MIDI tracks and I played the soprano sax. These three instruments trade short solos in a smooth dialogue which represents the changing of the baton in the 4 x 100 sprint relay event.

Bob Antolin is a producer, composer, band leader and multi-instrumentalist. He began playing the saxophone and guitar in elementary school and went on to get a music degree from the University of Washington. Loving classical music, jazz and music from around the world, Bob gets inspiration from every corner of the world. Bob was honored with the Golden Ear Award by Earshot Magazine for the Best Alternative Jazz Ensemble of the year in 2019 for his band, Comfort Food Band.
