A fighter being conducts a meeting with his spirit animal in a sacred shrine. There, he lays out his strategy and finalizes his command to his loyal beast.

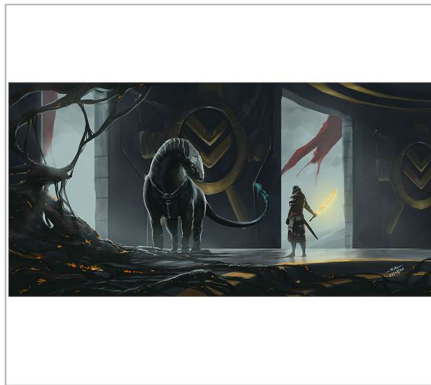
