Matteo's artworks are characterized by their vibrant colors and intricate patterns. He often uses his own fractal algorithms to generate the complex shapes and patterns that are his signature style.

In 2018, he teamed up with Jesper Nybroe, an expert in the VFX field. They created "Machina Infinitum," a VFX studio focused on the creation of digital art, motion graphics, and visual effects that are all based on fractals.
