Most if not all of my work is an interpretation of my personal experiences and visions gained through dreams and exploration of psychedelic spaces. These are mostly conceptual works/3D animations as in "Tranquil" or sometimes more fractal or geometric visualizations.
I hope to bring "other-worldly" experiences to a wider audience through 3D experiments. Messages that are often suppressed by mainstream publications due to the negative historical and social connotations that words like "psychedelics" or "plant medicine" usually carry.




